The state government recognition certificate has been renewed and extended till May 31st 2027. The District Education officer Ms. Jayakantham visited the school for inspection. She spent 3 to 4 hours in the school looking at all our learning and teaching materials in detail. She was in appreciation of the teaching methods, student-teacher interactions and the role of nature in the curriculum and campus which she wrote as feedback.
